Bidders need to apply for a digital ID with Bid Express at least 14 days prior to a scheduled bid opening date.

Electronic bids for MBTA Contract No. N19CN01R, READVERTISEMENT OF ON-CALL BUS PROJECTS, SYSTEMWIDE, MA, (CLASS 1, GENERAL TRANSIT CONSTRUCTION \$7,000,000) PROJECT VALUE – +/- \$9,999,539, can be submitted at www.bidx.com until two o'clock (2:00 p.m.) on November 20, 2025. Immediately thereafter, in a designated room, the Bids will be opened and read publicly.

Work consists of providing construction-related services on an on-call basis to support repair/reconstruction needs of the Authority. Work is anticipated to be performed throughout the MBTA service area and will primarily consist of the construction of new and altered bus stops, construction of bus lanes and other transit priority measures along roadways. Typical work includes pavement markings, signage, roadway paving, utility work, sidewalks, curb ramps, traffic signals, pedestrian signals, raised concrete platforms, bus shelters and canopies, lighting, communications, Security cameras, landscaping, traffic control devices and other work as identified by the Authority.

Bid Guaranty shall consist of a bid deposit in the amount of five (5) percent of the value of the bid, in the form of a bid bond, cash, certified check, treasurer's or cashier's check.

The successful Bidder shall be required to furnish a Performance Bond and a Labor and Materials Payment Bond each for the full amount of the Contract price.
